



## Team GB Gold Club Terms and Conditions and Privacy Policy

You have been nominated by your national governing body to be part of the Team GB Gold Club. The Team GB Gold Club is a scheme operated by the British Olympic Association ("**BOA**") and offers a number of benefits to its members. These benefits are provided by BOA partners and other third parties ("**Benefit Providers**").

In order to receive the majority of these benefits and discounts, the Team GB Gold Club member **must sign and return the enclosed application form**, and agree to the following terms and conditions.

### Terms of Use

The Team GB Gold Club card is for the sole use of the Team GB Gold Club member. Benefits provided are for the use of the Team GB Gold Club member only, unless otherwise indicated within the Benefit Terms and Conditions.

Benefit Providers may require the Team GB Gold Club member to agree to or sign a separate agreement in return for the benefit(s) provided, or otherwise require Team GB Gold Club Members to adhere to certain terms and conditions ("**Benefit Terms and Conditions**").

The BOA reserves the right to amend, remove or add Team GB Gold Club benefits at any time.

The BOA is not responsible for the processing of any of these benefits nor is it responsible or shall it have any liability in connection with any benefit, including the provision, withdrawal of or failure to provide any benefit

### Use of information

In order to receive benefits of the Gold Club, it will be necessary for the BOA to hold and process your personal data (including name, contact details and date of birth) on its database, which is hosted by a third party (Innervate) within the EEA. It may also be necessary for the BOA to pass on some or all of these details to Benefit Providers if required to activate a benefit, or to other third parties such as email service providers.

You acknowledge that the BOA may use the information provided by you for internal purposes related to your participation as a member of the Team GB Gold Club, e.g. (but not limited to) to update its internal records and for the purposes of communicating key information to you relating to the Team GB Gold Club.

Other than for the purposes set out above, the BOA shall not disclose your personal information to any third parties and shall keep such information confidential unless otherwise agreed with

you. The BOA also puts measures in place to keep your personal data as secure as possible on its systems.
